## **The use of cookies**

Although cookies usually remain active only for the duration of one visit, certain cookies are stored in the computer's memory in a cookie file while others expire or are deleted. Every cookie has an expiration date. Cookies are stored in a particular browser on a particular device, which means that when the user is working from another device the cookie will not be present there.
